

# Contact and Rockgas 2019 Dual Fuel Promotion Terms and Conditions

1 The promoter of the 2019 Dual Fuel Promotion (the **Promotion**) is Contact Energy Limited (“us/we/Contact”).

2 The Promotion is open to new residential and SME customers who sign up to Contact electricity AND Rockgas LPG during the Promotion Period. For the avoidance of doubt, the customer must sign up to both fuels to be eligible to enter the Promotion.

## Prize

3 Entries for the Promotion will open on 14 October 2019 and will close at 11.59pm on 15 December 2019 (the **Promotion Period**).

4 Each entrant who signs up in accordance with clause 2 above will receive one entry into the relevant prize draw during the Promotion Period and one entry into the Bonus Prize Draw at the end of the Promotion Period.

5 Each winner will be drawn within 10 working days from the close date of each respective prize draw.

6 There are 125 Mitre 10 gift cards to be won in this Promotion over the course of 4 separate prize draws. Entry into the prize draws will be determined on the following basis:

- (a) Prize Draw One: for new customers who have signed up in accordance with clause 2 above between 14 October 2019 and 3 November 2019;
- (b) Prize Draw Two: for new customers who have signed up in accordance with clause 2 above between 4 November 2019 and 24 November 2019;
- (c) Prize Draw Three: for new customers who have signed up in accordance with clause 2 above between 25 November 2019 and 15 December 2019; and
- (d) Bonus Prize Draw: for all new customers who have signed up in accordance with clause 2 above during the Promotion Period.

7 Each of the prize draws set out in clause 6(a), (b) and (c) will consist of the following prizes:

- (a) 1 x \$5,000 Mitre 10 gift card;
- (b) 3 x \$1,000 Mitre 10 gift cards; and
- (c) 36 x \$100 Mitre 10 gift cards (one for each Rockgas franchise area for customers who have signed up in accordance with clause 2 above in the relevant Rockgas franchise area),

(each a **Prize**).

8 The Bonus Prize Draw will consist of 5 x \$100 Mitre 10 gift cards (each a Bonus Prize).

14 No responsibility is taken for entries lost, delayed, misdirected or incomplete due to server functions, virus, bugs or other causes outside of our control.

15 Each Prize or Bonus Prize is non-exchangeable, non-transferable, and not redeemable for cash, cash equivalents or any other prize.

16 We retain the right to substitute each Prize or Bonus Prize with another prize of similar value in the event each original Prize or Bonus Prize offered is not available due to circumstances beyond our reasonable control.

17 By entering the Promotion you agree that we may use your personal information for promotional purposes and for the purposes of administering the Promotion and you agree to participate in any publicity arrangements that we may reasonably require without payment or other compensation.

18 We reserve the right to terminate, modify or suspend this Promotion without notice at any time.

19 We, our employees and agents shall not be liable for any loss, damage, injury or disappointment suffered or sustained (including, but not limited to, direct or consequential loss or loss arising from negligence) arising directly or indirectly out of or in connection with the Promotion or each Prize or Bonus Prize.
